

WHAT BENEFITS CAN CAPI PROVIDE?

Monthly cash assistance to help pay for living expenses such as:

- Rent
- Utilities
- Basic Needs

CAPI recipients may be eligible for CalFresh, Medi-Cal, and/or In-Home Supportive Services (IHSS); ask your worker for details.

HOW LONG WILL IT TAKE FOR MY APPLICATION TO BE PROCESSED?

Applications must be processed within 30 days from the date the completed application is received by the Adult Services (DPSS) office.

WHAT IS THE CASH ASSISTANCE PROGRAM FOR IMMIGRANTS (CAPI)?

CAPI provides monthly cash benefits to aged, blind, and disabled non-citizens (immigrants) who are not eligible for Supplemental Security Income/State Supplementary Payment (SSI/SSP) solely due to their immigrant status.



WHO IS ELIGIBLE?

You may be eligible for CAPI if you meet all of the following conditions:

- Are a non-citizen and meet the immigration status criteria in effect for SSI/SSP as of 8/21/1996.
- Are age 65 or over, blind, or disabled.
- Are ineligible for SSI/SSP solely due to your immigration status (This means you must apply for SSI/SSP, or submit other proof of ineligibility from the Social Security Administration).
- Reside in California.
- Have income less than the CAPI standards.
- Have resources below the allowable limits of \$2,000 for an individual or \$3,000 for a couple.
- Successfully complete the CAPI application process.



WHAT VERIFICATION WILL I NEED?

- **PROOF OF AGE:** Birth certificate or U.S. Citizenship and Immigration Services (USCIS) document that indicates date of birth, etc.
- **IDENTITY:** Valid driver's license/ ID, USCIS document with a photograph, or passport, etc.
- **IMMIGRANT/NON-CITIZEN STATUS:** Lawful Permanent Resident (LPR) card or Permanent Residence Under Color of Law (PRUCOL) verification.
- **SOCIAL SECURITY NUMBER (SSN):** Social Security card, Social Security award letter, Medicare card, or USCIS document that includes the SSN.
- **SSI INELIGIBILITY OR PENDING SSI APPLICATION STATUS** within six months of CAPI application.
- **PROOF OF RESIDENCY:** Rent or mortgage receipt or utility bill.
- **PROOF OF INCOME:** Pension, annuity, unemployment/disability stubs, or pay stubs, if applicable.
- **PROPERTY/RESOURCES:** Bank account statements, savings bonds, stock certificates, life insurance policies, and/or vehicle registration, if applicable.
- **AFFIDAVITS OF SUPPORT** for sponsored immigrants.
