

Deferred Action for Childhood Arrivals (DACA) Checklist



ELIGIBILITY REQUIREMENTS

- Low-Income proof to be eligible for free application assistance.
- Born on or after June 16, 1981
- Came to the United States before reaching 16th birthday
- Have continuously resided in the U.S. since June 15, 2007 up to the present time
- If previously deported, ordered removed, or left the US during this period, DISCUSS WITH AN IMMIGRATION ATTORNEY
- Were physically present in the United States on June 15, 2012, and at the time of making DACA application
- Entered without inspection, or lawful immigration status expired as of June 15, 2012
- Are currently in school, have graduated from high school, or obtained a general education certificate (GED)
- Have NOT been convicted of a felony, significant misdemeanor, three or more other misdemeanors, and do not otherwise pose a threat to national security or public safety
- If you have any arrests or criminal convictions, DISCUSS WITH AN ATTORNEY
- Be at least 15 years old to file an application (unless you are or have been in deportation proceedings)

<input type="checkbox"/> If you have been in deportation proceedings or entered with a visa, proof of expired immigration status	<ul style="list-style-type: none"> • Form I-94/I-95/I-94W with authorized stay expiration date • Final order of exclusion, deportation, or removal issued as of 6/15/2012 • A charging document placing you into removal proceedings • DISCUSS THESE ISSUES WITH AN ATTORNEY
<input type="checkbox"/> Proof you continuously resided in U.S. since June 15, 2007 and that you were present in the U.S. on June 15, 2012	<ul style="list-style-type: none"> • Rent receipts, utility, cell phone bills • Employment records (pay stubs, W-2 Forms, etc) • School records (transcripts, letters, report cards, etc) • Military records (Form DD-214 or NGB Form 22) • Official records from a religious entity confirming participation in a religious ceremony • Copies of money order receipts for money sent in or out of the country

<p><input type="checkbox"/> If you have ever been arrested by the police or any government agency</p>	<ul style="list-style-type: none"> <input type="checkbox"/> Obtain copies of police reports and court records for any arrests, criminal convictions or juvenile cases. <input type="checkbox"/> MAKE SURE TO DISCUSS THESE ISSUES WITH AN ATTORNEY BEFORE SUBMITTING ANY OF THIS DOCUMENTATION
